COMMISSION STAFF'S SUPPLEMENTAL REQUEST FOR INFORMATION  
TO KENTUCKY POWER COMPANY

Kentucky Power Company ("Kentucky Power"), pursuant to 807 KAR 5:001, is to file with the Commission its electronic responses and a paper original of the following information, with a copy to all parties of record. The information requested herein is due by March 29, 2013. Responses to requests for information shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Kentucky Power shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though

correct when made, is now incorrect in any material respect. For any request to which Kentucky Power fails or refuses to furnish all or part of the requested information, it shall provide a written explanation of the specific grounds for its failure to completely and precisely respond. Careful attention shall be given to copied material to ensure that it is legible.

1. Refer to Kentucky Power's response to Item 41 of the Commission's February 12, 2013 Request for Information ("February 12, 2013 Request"). The response states that "KPCo did not charge the FAC for kWh billed under Tariff RTP." For the period under review, during months in which Kentucky Power had sales under Tariff RTP, provide the total number of kWh sales under Tariff RTP for each month.

2. Refer to Kentucky Power's response to Item 42 of the February 12, 2013 Request and page 4 of 5 of the monthly FAC filings. For the period under review, during months in which Kentucky Power had sales under Tariff RTP, answer the following:

a. Refer to line 2 of the monthly FAC filings, titled "Retail KWH Billed at Above Rate." Does the number of kWh shown include the number of kWh sales under Tariff RTP?

b. Refer to line 4 of the monthly FAC filings, titled "KWH Used to Determine Last FAC Rate Billed." Does the number of kWh shown include the number of kWh sales under Tariff RTP?

c. Refer to line 6 of the monthly FAC filings, titled "Kentucky Jurisdiction KWH Included in L4 (L4 – L5)." Does the number of kWh shown include the number of kWh sales under Tariff RTP?

d. Refer to line 9 of the monthly FAC filings, titled "Total Sales (Page 3)." Does the number of kWh shown include the number of kWh sales under Tariff RTP?

e. Refer to line 10 of the monthly FAC filings, titled "Kentucky Jurisdiction Sales." Does the number of kWh shown include the number of kWh sales under Tariff RTP?
