COMMISSION STAFF'S SUPPLEMENTAL REQUEST FOR INFORMATION  
TO BIG RIVERS ELECTRIC CORPORATION

Big Rivers Electric Corporation ("Big Rivers"), pursuant to 807 KAR 5:001, is to file with the Commission the original and six copies of the following information, with a copy to all parties of record. The information requested herein is due on or before March 29, 2013. Responses to requests for information shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Big Rivers shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which


Big Rivers fails or refuses to furnish all or part of the requested information, Big Rivers shall provide a written explanation of the specific grounds for its failure to completely and precisely respond. Careful attention shall be given to copied material to ensure that it is legible.

1. Refer to Big Rivers' response to Item 38 of the Commission's February 13, 2013 Request for Information ("February 13, 2013 Request").

a. Big Rivers was requested to provide its generating units in economic dispatch order. The order was not provided. Provide a listing of Big Rivers' generating units in economic dispatch order.

b. When the Midwest Independent Transmission System Operator ("MISO") requires Big Rivers to run its generating units out of economic dispatch order, is Big Rivers compensated for doing so? Explain the response.

2. Refer to Big Rivers' response to Item 41 of the February 13, 2013 Request. The last sentence of the response states: "The start-up fuel cost portion of the MISO make-whole payments is what is being credited in the monthly FAC Form A filings on page 2 of 4." State whether the response means that start-up fuel costs are the only amounts that are credited in the monthly FAC filings on the line item "MISO Make Whole Payments."
