ORDER

Hardin County Water District No. 1 ("Hardin District") has moved to file its response to Commission Staff's Second Request for Information outside of the time set forth in the Commission's Order of July 30, 2013. Pursuant to this Order, Hardin District was to submit its response to Commission Staff's Second Request for Information no later than August 27, 2013. Hardin District further moves to amend the existing procedural schedule for this case.


In support of its motions, Hardin District states that this case is its first request for sewer rate adjustment and that its response to Commission Staff's First Request for Information consisted of over 1,500 pages requiring more than two weeks for Hardin District's chief financial officer, accounting department, and general manager to compile the requested information. Hardin District received Commission Staff's Second Request for Information on August 15, 2013, while it was preparing its response to Commission Staff's First Request for Information. Hardin District states that it has been unable to fully and thoroughly address Commission Staff's Second Request for Information in the allotted time.

Having considered the motions, the Commission finds that the motions should be granted.


IT IS THEREFORE ORDERED that:

1. Hardin District's motion for an extension of time until September 13, 2013 to respond to Commission Staff's Second Request for Information is granted.
2. Hardin District shall have until September 13, 2013 to file with the Commission its response to Commission Staff's Second Request for Information and to serve a copy on all parties of record.
3. Hardin District's motion to revise the procedural schedule set forth in the Commission's Order of July 30, 2013 is granted.
4. The procedural schedule set forth in the Order of July 30, 2013 is rescinded.
5. The procedural schedule set forth in the Appendix to this Order shall be followed.
6. All other provisions of the Commission's Order of July 30, 2013 remain in full force and effect.
7. The informal conference currently scheduled for November 26, 2013 is cancelled.
