ORDER

On March 13, 2013, Kenergy Corp. ("Kenergy") filed revised tariff sheets incorporating revisions to its existing demand-side management ("DSM") programs. Kenergy proposes revisions to the following existing DSM programs: (1) High Efficiency Lighting Replacement Program, First Revised Sheet No. 47; (2) Energy Star Clothes Washer Replacement Incentive Program First Revised Sheet No. 48; (3) Energy Star Refrigerator Replacement Incentive Program, First Revised Sheet No. 49; (4) Residential & Commercial High Efficiency Heating, Ventilation and Air Conditioning ("HVAC") Program, First Revised Sheet No. 50 and First Revised Sheet No. 50A; (5) Touchstone Energy New Home Program, First Revised Sheet No. 51; (6) Residential and Commercial HVAC & Refrigeration Tune-Up Program, First Revised Sheet No. 52; (6) Commercial / Industrial High Efficiency Lighting Replacement Incentive Program, First Revised Sheet No. 53; (7) Commercial/Industrial General Energy Efficiency Program, First Revised Sheet No. 54; (8) Residential Weatherization Program – Primary Heating Source Non-Electric and Electric-Sourced Air Conditioning, First Revised Sheet No. 55 and First Revised Sheet No. 55A; (9) Residential Weatherization Program – Primary Heating Source Electric and Electric-Sourced Air Conditioning, First Revised

Sheet No. 56 and First Revised Sheet No. 56A. Kenergy also proposed revisions to page 3 of its Table of Contents.

Except for its proposed revisions to page 3 of its Table of Contents, which did not contain a proposed effective date, the remaining tariffs contained an effective date of March 25, 2013. By Order issued March 22, 2013, the Commission approved the following tariffs for service rendered on and after April 12, 2013:

1. High Efficiency Lighting Replacement Program, First Revised Sheet No. 47;
2. Energy Star Clothes Washer Replacement Incentive Program First Revised Sheet No. 48;
3. Energy Star Refrigerator Replacement Incentive Program, First Revised Sheet No. 49;
4. Touchstone Energy New Home Program, First Revised Sheet No. 51;
5. Commercial/Industrial High Efficiency Lighting Replacement Incentive Program, First Revised Sheet No. 53; and
6. Commercial/Industrial General Energy Efficiency Program, First Revised Sheet No. 54.

KRS 278.180(1) states that no change shall be made by any utility in any rate except upon thirty (30) days' notice to the Commission. The Commission further found in the March 22, 2013 Order that an investigation would be necessary to determine the reasonableness of Kenergy's proposed changes to:

7. Residential & Commercial High Efficiency Heating, Ventilation and Air Conditioning (“HVAC”) Program, First Revised Sheet No. 50 and First Revised Sheet No. 50A;

8. Residential and Commercial HVAC & Refrigeration Tune-Up Program, First Revised Sheet No. 52;

9. Residential Weatherization Program – Primary Heating Source Non-Electric and Electric-Sourced Air Conditioning, First Revised Sheet No. 55 and First Revised Sheet No. 55A;

10. Residential Weatherization Program – Primary Heating Source Electric and Electric-Sourced Air Conditioning, First Revised Sheet No. 56 and First Revised Sheet No. 56A; and

11. That portion of Page 3 of its Table of Contents containing the tariffs that were suspended.

In that same Order, the Commission suspended the effective date of the proposed tariffs identified in findings paragraphs 7, 8, 9, and 10 and 11 from April 12, 2013 for five months, up to and including September 11, 2013.

#### DISCUSSION

Kenergy’s proposed changes to its tariffs are consistent with the approvals granted in Big Rivers Electric Corporation (“Big Rivers”) Case No. 2013-00099.<sup>1</sup>

Kenergy’s proposed changes to its Residential & Commercial High Efficiency Heating, Ventilation and Air Conditioning (“HVAC”) Program, First Revised Sheet No. 50 and First Revised Sheet No. 50A are consistent with the changes approved to Big

Rivers' DSM-04 and the addition of Big Rivers' newly proposed DSM-11, Commercial High Efficiency Heating, Ventilation, and Air Conditioning ("HVAC") Program.<sup>2</sup>

Kenergy's proposed changes to its Residential and Commercial HVAC & Refrigeration Tune-Up Program, First Revised Sheet No. 52 are consistent with the proposed changes in Big Rivers' DSM-07, Residential and Commercial HVAC & Refrigeration Tune-Up Program.

Kenergy's proposed changes to its Residential Weatherization Program – Primary Heating Source Non-Electric and Electric-Sourced Air Conditioning, First Revised Sheet No. 55 and First Revised Sheet No. 55A are consistent with the proposed changes in Big Rivers' DSM-10, Residential Weatherization Program – Primary Heating Source Non-Electric.

Kenergy's proposed changes to its Residential Weatherization Program – Primary Heating Source Electric and Electric-Sourced Air Conditioning, First Revised Sheet No. 56 and First Revised Sheet No. 56A are consistent with the proposed changes in Big Rivers' DSM-05 Residential Weatherization Program.

Having reviewed the record and being otherwise sufficiently advised, the Commission finds that because Kenergy's proposed tariff changes are consistent with

In Case No. 2013-00099, Big Rivers' proposed new DSM-11, Commercial High Efficiency Heating, Ventilation, and Air Conditioning ("HVAC") Program was approved, as well as changes to its DSM-04, Residential High Efficiency Heating, Ventilation and Air Conditioning ("HVAC") Program.

the applicable approvals<sup>3</sup> granted to Big Rivers in Case No. 2013-00099, Kenergy's proposed changes to its DSM tariffs are reasonable and should be approved.

IT IS HEREBY ORDERED that:

1. Kenergy's proposed changes to its Residential & Commercial High Efficiency Heating, Ventilation and Air Conditioning ("HVAC") Program, First Revised Tariff Sheet Nos. 50 and 50A are approved for service on and after the date of this Order.

2. Kenergy's proposed changes to Residential and Commercial HVAC & Refrigeration Tune-Up Program, First Revised Tariff Sheet No. 52 are approved for service on and after the date of this Order.

3. Kenergy's proposed changes to its Residential Weatherization Program – Primary Heating Source Non-Electric and Electric-Sourced Air Conditioning, First Revised Tariff Sheet Nos. 55 and 55A are approved for service on and after the date of this Order.


4. Kenergy's proposed changes to its Residential Weatherization Program – Primary Heating Source Electric and Electric-Sourced Air Conditioning, First Revised Tariff Sheet Nos. 56 and 56A are approved for service on and after the date of this Order.


<sup>3</sup> Although a new High Efficiency Outdoor Lighting Program – DSM-12 was approved for Big Rivers in Case No. 2013-00099, there are no changes proposed to Kenergy's Schedule 15 – Private Outdoor Lighting program in this proceeding. Changes to Kenergy's Schedule 15 were approved effective December 1, 2012 in Tariff Filing TFS2012-00915. Also, changes to Kenergy's Schedule 15 were approved for service rendered on and after September 1, 2011 pursuant to an Order issued January 29, 2013 in Case No. 2011-00035, Application of Kenergy Corp. for an Adjustment in Existing Rates.

5. Within 20 days of the date of this Order, Kenergy shall file with the Commission its tariff sheets as approved herein indicating the date of issue, the effective date, and that they were issued by authority of this Order.
