ORDER


IT IS THEREFORE ORDERED that:

1. A hearing shall be scheduled for Wednesday, November 13, 2013, at 10:00 a.m., Eastern Standard Time, in Hearing Room 1 of the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky.
2. Columbia shall publish notice of this hearing in compliance with 807 KAR 5:001, Section 9(2)(b). At the time publication is requested, Columbia shall forward a duplicate of the notice and request to the Commission.
3. Columbia shall file with the Commission no later than November 12, 2013, proof of publication of its notice of the hearing in each of the publications in which it published notice.
4. The official record of these proceedings shall be by video only.
5. Any request to cancel or postpone this hearing shall be made by motion filed with the Commission at least one week before the hearing is scheduled to commence.
