ORDER

On April 29, 2004, in Case No. 2003-00411,¹ the Commission approved rates for Equitable Gas Company, a division of Equitable Resources, Inc. ("Equitable"), and provided for their further adjustment on a quarterly basis in accordance with Equitable's Gas Cost Adjustment ("GCA") clause.

On June 20, 2013, Equitable filed its proposed GCA to be effective August 1, 2013.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Equitable's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Equitable's Expected Gas Cost ("EGC") is \$5.3616 per Mcf, which is a decrease of \$.3705 per Mcf from its previous EGC of \$5.7321 per Mcf.
3. Equitable's notice sets out no Refund Adjustment.

4. Equitable's notice sets out a current quarter Actual Adjustment ("AA") of (\$.0654) per Mcf. Equitable's total AA is (\$.4452) per Mcf, which is a decrease of \$.0961 per Mcf from the previous total AA of (\$.3491) per Mcf.

5. Equitable's notice sets out a current quarter Balancing Adjustment ("BA") of (.0177) per Mcf. Equitable's total BA is (\$.1718) per Mcf, which is an increase of \$.0128 per Mcf from the previous total BA of (\$.1846) per Mcf.

6. Equitable's Gas Cost Recovery Rate is \$4.7446 per Mcf, which is a decrease of \$.4538 per Mcf from its previous rate of \$5.1984 per Mcf.

7. The rates in the Appendix to this Order are fair, just, and reasonable and should be approved for final meter readings by Equitable on and after August 1, 2013.

IT IS THEREFORE ORDERED that:


1. The rates in the Appendix to this Order, attached hereto and incorporated herein, are approved for final meter readings on and after August 1, 2013.

2. Within 20 days of the date of this Order, Equitable shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
