ORDER

Water Service Corporation of Kentucky ("WSKY") has moved for an additional 14 days to file its responses to Requests for Information issued by Commission Staff and the Attorney General on October 25, 2013. Pursuant to the Commission's Order entered October 18, 2013, WSKY was to submit its responses to these Requests for Information no later than November 8, 2013. WSKY further moves for a corresponding amendment to the dates in the procedural schedule.

In support of its motions, WSKY states that on October 25, 2013, Commission Staff issued an information request containing 23 items with numerous subparts, and the Attorney General issued a request for information containing 113 items with several subparts. To properly and sufficiently respond to both requests for information, WSKY requests a 14-day extension. WSKY further proposes to change the subsequent procedural dates, but to keep the informal conference as currently scheduled on February 25, 2014.

WSKY advises that the intervenors, the Attorney General and Hickman County Fiscal Court, have no objection to the extension and revision of the procedural schedule.¹



Having considered the motion, the Commission finds that the motion should be granted and a revised procedural schedule is set forth in the Appendix to this Order.


IT IS THEREFORE ORDERED that:

2. The procedural schedule set forth in the Appendix to this Order shall be followed and shall replace the procedural schedule set forth in the Order of October 18, 2013.
3. All other provisions of the October 18, 2013 Order shall remain in full force and effect.
