ORDER

On July 1, 2013, Levee Road Water Association ("Levee Road") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Levee Road purchases water from Mount Sterling Water and Sewer System ("Mount Sterling").

2. On July 1, 2013, Mount Sterling increased its volumetric rate to Levee Road from \$2.41 per 1,000 gallons to \$2.46 per 1,000 gallons.<sup>2</sup>

3. On July 1, 2013 Levee Road adjusted its rates for water service to reflect the increased cost of purchasing water from Mount Sterling. Levee Road used a purchased water adjustment factor of \$0.06 per 1,000 gallons.

4. During the 12 months ended May 31, 2013, Levee Road purchased 51,285,721 gallons of water from Mount Sterling, and sold 44,381,950 gallons of water. As a result of the increase in Mount Sterling's wholesale rate, Levee Road's cost of purchased water will increase \$2,564.29, resulting in a purchased water adjustment factor of \$0.06 per 1,000 gallons.


5. The purchased water adjustment factor of \$0.06 per 1,000 gallons as calculated in Appendix A to this Order is fair, just, and reasonable and should be approved.

6. The rates set forth in Appendix B to this Order are fair, just, and reasonable and should be approved for water service that Levee Road provides on and after July 1, 2013.

IT IS THEREFORE ORDERED that:

1. Levee Road's proposed rates are approved.
2. The purchased water adjustment factor of \$0.06 per 1,000 gallons is approved.
3. The rates set forth in Appendix B, are approved for service that Levee Road rendered on or after July 1, 2013.
4. Within 20 days of the date of this Order, Levee Road shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the approved rates.
