ORDER

On October 31, 2008, in Case No. 2008-00032,¹ the Commission approved rates for Burkesville Gas Company, Inc. ("Burkesville") and provided for their further adjustment on a monthly basis in accordance with Burkesville's Gas Cost Adjustment ("GCA") clause.

On July 1, 2013, Burkesville filed its proposed GCA with a proposed effective date of August 1, 2013.

After reviewing the evidence of record and being otherwise sufficiently advised, the Commission finds that:

1. Burkesville's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Burkesville's proposed Expected Gas Cost ("EGC") is \$8.1488 per Mcf, which is an increase of \$.0205 per Mcf from the prior EGC of \$8.1283 per Mcf.
3. Burkesville's notice sets out no Refund Adjustment.
4. Burkesville's notice sets out a current Actual Adjustment ("AA") of (\$.0524) per Mcf to reconcile over/under-recoveries of gas cost for April, May, and June 2013.

Pursuant to the terms of its newly revised GCA tariff, Burkesville should file its AA information for the quarter ending June 30, 2013 in its next application for rates effective October 1, 2013. Burkesville's total AA of \$.2334 per Mcf represents an increase of \$1.0843 per Mcf from the previous total AA of (\$.8509) per Mcf, and reflects the expiration of a previous month AA on August 1, 2013.

5. Burkesville's GCA is \$8.3822 per Mcf, which is an increase of \$1.1048 per Mcf from the previous GCA of \$7.2774 per Mcf.

6. The rates in the Appendix to this Order are fair, just, and reasonable and should be approved for service rendered by Burkesville on and after August 1, 2013. According to the terms of its recently revised tariff, Burkesville's next GCA filing is due September 1, 2013 for rates effective October 1, 2013.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Burkesville are denied.
2. The rates in the Appendix, attached hereto and incorporated herein, are approved for service rendered on and after August 1, 2013.
3. Within 20 days of the date of this Order, Burkesville shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
