ORDER


On September 27, 2013, Kentucky Power Company ("Kentucky Power") moved the Commission to schedule an informal conference in this matter and to extend the procedural schedule in this matter by three weeks. Kentucky Power states that it has determined that PJM marginal losses and credits, congestion costs and credits, and financial transmission rights were misallocated between its jurisdictional customers and off-system sales between July 2011 and June 2013. As a result of the misallocation, it states that an additional three weeks is required to enable the company to review and recalculate the information needed to prepare its testimony and data request responses. Kentucky Power additionally requests an informal conference be held to brief Commission Staff on the misallocation's effect on the environmental surcharge in this case, as well as its fuel adjustment clause billings in a companion case.¹

Kentucky Power having moved for an informal conference and changes in the procedural schedule in this matter, and the Commission finding that the motion should be granted, IT IS HEREBY ORDERED that:



1. Kentucky Power's motion is granted.
2. An informal conference shall be held on Monday, October 7, 2013, at 10:00 a.m. Eastern Daylight Time, at the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky, for the purpose of discussing the issues in this case.
3. The procedural schedule set forth in Appendix B of the Commission's September 11, 2013 Order is stricken and the procedural schedule appended hereto as Appendix A is substituted.
4. All provisions of the Commission's September 11, 2013 Order not in conflict with this Order shall remain in full force and effect.
