ORDER

On July 5, 2011, in Case No. 2011-00010,<sup>1</sup> the Commission approved rates for Valley Gas, Inc. ("Valley Gas") and provided for their further adjustment on a quarterly basis in accordance with Valley Gas's Gas Cost Recovery ("GCR") clause.

On September 3, 2013, Valley Gas filed its GCR to be effective October 1, 2013.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Valley Gas's notice includes a revised rate designed to pass on to its customers its expected change in wholesale gas costs.
2. Valley Gas's proposed Expected Gas Cost ("EGC") is \$5.0259 per Mcf, which is a decrease of \$.1284 per Mcf from the previous EGC of \$5.1543 per Mcf.
3. Valley Gas's notice sets out no current quarter Refund Adjustment.
4. Valley Gas's notice sets out a current quarter Actual Adjustment ("AA") of (\$.0127) per Mcf. Valley Gas's total AA is (\$.0332) which is an increase of \$1.7013 per Mcf from the previous total AA of (\$1.7345) per Mcf.

5. Valley Gas's notice sets out a GCR of \$4.9927 per Mcf, which is an increase of \$1.5729 per Mcf from the previous GCR of \$3.4198 per Mcf.


6. The rate in the Appendix to this Order is fair, just, and reasonable and should be approved for service rendered by Valley Gas on and after October 3, 2013. Valley Gas did not give the 30 days' notice required for its rate increase to be effective October 1, 2013.

IT IS THEREFORE ORDERED that:

1. The rate in the Appendix attached hereto and incorporated herein is approved for service rendered on and after October 3, 2013.

2. Within 20 days of the date of this Order, Valley shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rate approved herein and reflecting that it was approved pursuant to this Order.
