ORDER OF ASSESSMENT FOR THE) ADMINISTRATIVE ORDER NO. 34

The utility companies operating in Kentucky, and subject to the jurisdiction of the Commission, having reported to the Commission, or the Commission otherwise having the information, their gross receipts derived from intrastate business in Kentucky for the calendar year ended December 31, 1939; and the Commission having determined that its maintenance expenses during the fiscal year ending June 30, 1941, will be approximately one hundred thirty thousand (\$130,000) dollars, the Commission does hereby apportion among and assess the cost thereof upon said utility companies in proportion to the gross earnings or receipts of said utility companies derived from intrastate business in Kentucky for the calendar year ended December 31, 1939, as set forth as follows:
