A meeting of the Public Service Commission was held this date, Present: Chairman Robert M. Coleman and Commissioners Cass R. Walden and H. Clay Kauffman.

PROCEDURE.

Administrative Order No. 69

ORDER

The Commission, upon its own motion and pursuant to the authority contained in KRS 278, as amended, hereby amends its rules of procedure as follows:

RULE V. Section 6 is amended and, when amended, reads as follows:

Whenever in these rules it is provided that a financial statement shall be annexed to the application, the statement shall cover a full year's operation and be prepared as of the close of the latest quarter in which the application is filed and shall show the following information in order:

RULE VI. Section 1, Subsection (a) is amended and, when amended, reads as follows:

A general description of applicant's property and the field of its operation, together with a statement of the original cost of the same and the cost to the applicant. If it is impossible to state the original cost, the facts creating such impossibility shall be stated.

RULE VIII is amended and, when amended, reads as follows:

APPLICATION OR NOTICE FOR AUTHORITY TO ADJUST RATES.

When any public utility seeks to adjust any rate, fare, toll, charge, or rental, so as to alter any classification, contract, practice, rule, or regulation as to result in any change in any rate, fare, toll,

charge, or rental, applicant, in addition to complying with the provisions of Rule V, shall submit the following data either in the application or attached thereto as exhibits:

- (a) Copy of Articles of Incorporation (Rule V - 5)
- (b) Financial statement (Rule V - 6)
- (c) A schedule of the present rates, fares, tolls, charges, or rentals, in effect, and the changes which it is desired to make. (See Rule XI).
- (d) The description of applicant's property, including a statement of the original cost of the property, and the cost thereof to applicant.
- (e) A statement in full of the reason why the increase is desired so that the Commission may clearly see the justification therefor.

RULE X, Section 2 is hereby amended and, when amended, reads as follows:

Notice of the place, day, and hour of the hearing in a formal case will be served at least twenty days before the time set therefor. Hearings upon formal applications will be set as deemed necessary by the Commission (See Form No. 4).

The amendments herein prescribed be, and they are hereby, made effective as of the date of this order.

The Secretary of the Commission shall cause prompt distribution of this order to all utilities subject to the jurisdiction of this Commission.
