O R D E R

Utility companies operating in the State of Kentucky and subject to the jurisdiction of the Public Service Commission of Kentucky, having reported to the Commission their gross receipts derived from intrastate business in Kentucky for the calendar year ended December 31, 1958, and it having been determined that it is necessary to make an assessment in the amount of \$250,000.00 for the maintenance of the Commission during the fiscal year ending June 30, 1960, the Commission hereby does apportion among and assess the amount of \$250,000.00 upon said utility companies.

These amounts so assessed are in proportion to the gross receipts derived from intrastate business in Kentucky for the calendar year ended December 31, 1958, except that the assessment upon any utility is not less than \$5.00, as provided by K.R.S. 278.130 as amended and re-enacted by Senate Bill 131, 1952 Legislature.

IT IS THEREFORE ORDERED That the following utilities be, and they hereby are, assessed as follows:
