The Commission, realizing the need for a revision of its rules and regulations, prepared such revisions, which, after due notice to all the utilities affected, were presented at public hearings in the Commission's offices at Frankfort, Kentucky.

After consideration of the comments and suggestions offered by those in attendance at said hearings, the Commission promulgated its revised regulations.

The Commission, on its own motion, ORDERS:

1. That Regulation PSC: Proc - 1, consisting of Rules of Procedure, numbered 1 through XIV-4 attached hereto as Appendix "A", be and it hereby is adopted.

2. That Regulation PSC: Gen - 1, consisting of General Rules Governing Electric, Water, Gas and Telephone Utilities, numbered 1 through XXI, attached hereto as Appendix "B", be and it hereby is adopted.

3. That Regulation PSC: Tar - 1, consisting of Rules Governing Tariffs, numbered 1 through XIII-6, attached hereto as Appendix "C", be and it hereby is adopted.

4. That Regulation PSC: Elec - 1, consisting of Rules Governing Electric Utilities, numbered I through XXII, attached hereto as Appendix "D", be and it hereby is adopted.

5. That Regulation PSC: Gas - 1, consisting of Rules Governing Gas Utilities, numbered I through XX, attached hereto as Appendix "E", be and it hereby is adopted.

6. That Regulation PSC: Gas, Sp - 1, consisting of Rules Governing Gas Service From Producing Gas Wells and Gathering Pipe Lines Under ERS 278.085, numbered I through X, attached hereto as Appendix "F", be and it hereby is adopted.

7. That Regulation PSC: Telep - 1, consisting of Rules Governing Telephone Utilities, numbered I through XX, attached hereto as Appendix "G" be and it hereby is adopted.

8. That Regulation PSC: V - 1, consisting of Rules Governing Water Utilities, numbered I through XVII, attached hereto as Appendix "H", be and it hereby is adopted.

9. That the Rules of Procedure adopted by the Commission on the 10th day of August 1934, and all amendments thereto, be and they hereby are superseded.

10. That the Rules and Regulations for the Government of Construction and Filing of Tariffs of Public Utilities adopted by the Commission on the 15th day of August 1934, and effective the 20th day of August 1934, and all amendments thereto, be and they hereby are superseded.


11. That Administrative Order No. 5, consisting of Rules and Regulations for the Government of Electric, Gas and Water Utilities and all amendments thereto, be and they hereby are superseded.

12. That Administrative Order No. 91, consisting of Rules and Regulations for Gas Service under KRS 278.485, as amended, and all amendments thereto, be and they hereby are superseded.
