ORDER

On the 3rd day of January, 1978, the Secretary of the Public Service Commission forwarded two (2) copies of the Report of Gross Operating Revenues derived from intrastate business for the year ended December 31, 1977. The aforementioned Section states that the Report shall be filed on or before March 31 relating to business for the preceding calendar year. It was indicated that should the Report not be received on or before April 28, 1978, it would be necessary for the Commission to initiate such legal action as provided by applicable Kentucky Statutes.
