O R D E R

On April 1, 1979, House Bill 547 amending KRS Chapter 278 became law. Pursuant to KRS 278.040(2), as amended, the jurisdiction extending over all utilities in Kentucky, formerly vested in the Public Service Commission, was transferred to two new commissions, Energy Regulatory Commission and Utility Regulatory Commission.

KRS 278.040(2) states, in part, as follows: "... the utility regulatory commission shall have exclusive jurisdiction over the regulation of rates and service of all non-energy utilities."

Accordingly, the Utility Regulatory Commission assumes jurisdiction over the cases listed herein pending before the Public Service Commission of Kentucky on March 31, 1979.
