
Pursuant to Section 4.5.2 of AT&T Kentucky's Self Effectuating Enforcement Mechanisms Administration Plan ("SEEM Plan"), AT&T Kentucky hereby declares a force majeure event in the attached NPAs/NXXs as of January 27, 2009 due to the effects of last week's ice and snow storm. The measures affected due to the force majeure event include all measures associated with Provisioning, Maintenance and Repair, and Trunk Group Performance.

The storm adversely affected all sections of Kentucky, but the worst damage is in the western part of the Commonwealth. Governor Beshear declared a State of Emergency for Kentucky on January 27, 2009.

It will take some time for AT&T Kentucky to recover and regain normal installation and repair activities. AT&T Kentucky will provide updates on our recovery efforts and advise the Commission when the service emergency period is concluded. AT&T Kentucky views this storm as a force majeure event, relieving AT&T Kentucky of any SEEM payment for the above-mentioned measures during the time period of the force majeure event.
