Consistent with Appendix F of the Service Quality Measurements Plan adopted by this Commission on August 31, 2005, BellSouth Telecommunications, Inc. d/b/a AT&T Kentucky ("AT&T Kentucky") is filing a Proposed Data Notification Report for May 2008 data month. There are no changes for the May 2008 Proposed Data Notification Report. Therefore, the industry call scheduled for April 7, 2008, has been cancelled.

AT&T Kentucky would like to clarify one additional matter for the Commission and the Parties. In its March 3, 2008, filing of the May 2008 Preliminary Data Notification Report, AT&T Kentucky stated that it provided notice on June 1, 2007, that it would modify PMAP to capture the latest version of the LSR for orders by performing additional lookups. Although AT&T Kentucky expected to make the change with August 2007 data, it was to be implemented with February 2008 data instead. Since AT&T Kentucky's March 3, 2008, filing, this modification has been completed.
