Consistent with Appendix F of the Service Quality Measurements Plan adopted by this Commission on August 31, 2005, BellSouth Telecommunications, Inc. d/b/a AT&T Kentucky ("AT&T Kentucky") is filing a Proposed Data Notification Report for May 2007 data month. The May 2007 changes will be discussed at the April 6, 2007, industry conference call.

There is an additional matter that AT&T Kentucky would like to bring to the attention of the Commission and the parties. In its November 2006 Data Notification, which was filed on September 29, 2006, AT&T Kentucky provided notice that for two OSS-1 measures, re-posting could not be determined at the time of the filing due to the complexity of the measure.
