Consistent with Appendix F of the Service Quality Measurements Plan adopted by this Commission on August 31, 2005, BellSouth Telecommunications, Inc. d/b/a AT&T Kentucky ("AT&T Kentucky") is filing a Preliminary Data Notification Report for January 2009 data month. These changes will be discussed at the November 10, 2008, industry conference call.

AT&T Kentucky has established a schedule for the industry conference calls that will be conducted during the year of 2009. The conference calls will be held on January 7, February 6, March 6, April 7, May 7, June 5, July 8, August 7, September 4, October 7, November 6, and December 4, 2009, and will be conducted at 2:00 p.m. (Eastern Time). AT&T Kentucky has taken the liberty of preparing a schedule (a copy of the 2009 schedule is enclosed) outlining these calls as well as the deadlines for AT&T Kentucky's filing written notification of proposed data changes and for interested parties' filing comments with the Commission.

As set forth in the 2009 PMAP Notification Schedule and referenced in its recently revised 2008 Schedule (filed on September 2, 2008), AT&T Kentucky has established a new conference bridge for all future industry calls. The conference bridge for these calls will remain the same, which is 877-888-4443 (toll free within the AT&T calling area). Beginning on January 7, 2009, the participant PIN will be 2636161#. This PIN has been established to allow other members to open the bridge in the event the conference leader is unavailable.
