Dear Mr. Derouen:

On September 8, 2010, AT&T Kentucky notified the Commission of proposed changes to the SQM/SEEM Plan submitted by AT&T Georgia for approval to the Georgia Public Service Commission on September 3, 2010. In that letter, AT&T Kentucky attached a copy of the Georgia filing which summarized the proposed changes. On December 13, 2010, the Georgia Public Service Commission approved the proposed changes to the Georgia SQM/SEEM Plan. A copy of that Order, which summarizes the changes, is attached hereto as **Exhibit A**.

The approved SQM/SEEM Plan changes are principally directed to streamlining the SQM/SEEM Plan, providing for certainty for the Plan over time and continuing to provide adequate assurance of continued good wholesale performance by AT&T. For the Commission's convenience, copies of the redlined modifications to the Plan are attached as **Exhibit B1** and **Exhibit B2**. AT&T Kentucky plans to implement the modified Plan in Kentucky in the March to May 2011 data month timeframe.

As further information, the Florida Public Service Commission provided its final approval on October 29, 2010, of similar changes to the Florida SQM/SEEM Plan after months of extensive and numerous workshops and conference calls opened to all interested parties wherein the proposed SQM and SEEM revisions were discussed and debated. The North Carolina Utilities Commission also approved similar changes to the North Carolina SQM/SEEM Plan on October 22, 2010.

In accordance with the Commission's previous Orders in the above-referenced dockets, AT&T Kentucky continues to operate under the Georgia Performance Plan, including any future modifications made to the Georgia Plan.
