Dear Mr. Derouen:

Pursuant to Section 4.5.2 of AT&T Kentucky's Self Effectuating Enforcement Mechanism Administration Plan ("Plan"), AT&T Kentucky hereby declares a Force Majeure Event beginning January 10, 2011, and ending January 16, 2011, due to the winter storm in the southeastern region of the country causing AT&T Kentucky to experience delays in processing for the Local Service Centers ("LSCs"), Access Service Centers ("ASCs") and Billing Centers.

AT&T's centers that serve the southeast region are located in Birmingham, Alabama, and Tucker, Georgia. The Governors of each state declared a statewide State of Emergency. The snow and icy conditions resulted in road closings with numerous other roads rendered impassable or blocked. For public safety concerns, citizens were encouraged not to drive their vehicles and stay off the highways. Hence, numerous AT&T personnel were unable to attend normal work shifts, therefore, negatively impacting AT&T's ability to perform its center operations. Accordingly, as it relates to performance that is measured by the Plan, the winter storm prevented AT&T Kentucky from meeting the performance standards associated with the metrics that measure the work activities of those centers, specifically:

- Reject Interval ("RI") (excluding Fully Mechanized)
- Firm Order Confirmation Timeliness ("FOCT") (excluding Fully Mechanized)
- Average Answer Time Ordering Centers ("OAAT")
- Mean Time to Deliver Invoices ("BIT") (excluding Invoices delivered electronically)
- Percent Billing Adjustment Requests Responded to within 45 Business Days ("BEC")
