On December 18, 2001, the Commission issued its order in Administrative Case 382, An Inquiry into the Development of Deaveraged Rates for Unbundled Network Elements, establishing rates for BellSouth's Unbundled Network Elements. On January 7, 2002, BellSouth filed a tariff to make those rates publicly available. On January 16, 2002, the attachment was refiled, under separate cover, to correct pagination errors.
