BELLSOUTH TELECOMMUNICATIONS, INC.'S RESPONSE TO THE COMMISSION STAFF'S DATA REQUEST DATED FEBRUARY 25, 2002

REQUEST NO. 1

A narrative description by BellSouth of each of the five areas which it identified to the Federal Communications

Commission ("FCC") as items of concern leading to the withdrawal of its Section 271 Application for Georgia and Louisiana.

BellSouth has refiled the application with the FCC having addressed the five areas. Commission Staff seeks a narrative description of each area as it relates to BellSouth's compliance with 47 U.S.C. § 271 in Kentucky. The five items are: (1) the timeliness of evidence demonstrating that competing carriers could integrate or have successfully integrated pre-ordering and ordering functionality; (2) BellSouth's performance on service order accuracy; (3) the accuracy of certain performance data; (4) the timeliness of evidence of the "double FOC" performance issue related to the due date calculator; and (5) the timeliness

of evidence related to the allocation of resources in the Change Control Process. 1

RESPONSE

On February 21, 2002, BellSouth filed its Response in Opposition to a Motion by AT&T, MCI, and SECCA which suggested that the Commission have additional process in this docket based on BellSouth's December 20, 2001, withdrawal of its 271 application to the FCC for the states of Georgia and Louisiana. The notice of withdrawal advised the FCC that BellSouth would shortly refile its application and address certain concerns raised by CLECs during the review process. BellSouth refiled its 271 application for Georgia and Louisiana on February 14, 2002. As part of that application, BellSouth addressed each of the five items listed in the Commission's Initial Data Request. BellSouth's February 21, 2002, response attached a copy of the February 14, 2002, Georgia/Louisiana filing with the FCC. material included BellSouth's brief which contains a detailed narrative regarding the five issues. Because the five issues are regional, BellSouth's response addresses these issues as they pertain to its 271 application in Kentucky. BellSouth previously provided the Commission one paper copy of the FCC
