Objective & Introduction

Purpose

This document provides a mapping of pre-order response fields to firm order fields and their corresponding forms. The pre-order response fields have been extracted from the BellSouth Pre-Order Business Rules Ver 9.0 document dated November 9, 2000. This field mapping is for ALL REQTYPES.

Audience

The intended audiences are the users of BellSouth's Pre-Order Systems.

Introduction

The purpose of this document is to provide a mapping matrix for Competitive Local Exchange Carriers (CLECs) that submit pre-orders and firm orders electronically and/or manually to BellSouth. It outlines the various pre-order response transactions, defines each field in each system within that response (see "Matrix Column Definitions" tab for more information), and maps them to the corresponding firm order field and form where applicable.

A brief synopsis of each pre-order response is as follows:

- Address Validation Responses (AVR)— The AVRs provide verification of the living unit's address, either as derived from a ten digit telephone number or a customer address.
- **Telephone Number Assignment Responses (TNAR)** The TNARs provide the CLEC with the ability to select / reserve telephone numbers.
 - **Note:** The TNAR **DID** (Direct Inward Dialing) will **NOT** be covered as it is not used with the UNEP product.
- Appointment Availability Response (AAR)— The AAr allows CLECs to view BellSouth's Central Office, Installation, and Maintenance calendar when coordinating installation of service.
- Service Availability Response (SAR)— The SAR allows CLECs to obtain service and feature availability and information on the BellSouth switches. It also allows CLECs to obtain PIC information.
- **Customer Service Record Response (CSRR)** The CSRR allows CLECs to view customer records.
- **Calculate Due Date Response (CDDR)** The CDDR allows CLECs to view what due date BellSouth will have a service completed.

This document does **NOT** provide information regarding if a particular field is conditional, optional, required, or prohibited. For this information, please consult the "BellSouth Pre-Order Business Rules".

Please note the appendix to this document, Appendix A – Examples of Pre-Order to Firm-Order Mapping for UNEP. This document contains six (6) different ordering scenarios and how the Pre-Order fields map to the Firm-Order fields when available. The scenarios contain example data.
