Pursuant to KRS 61.872, the Public Service Commission of Kentucky requests a copy of the following documents:

- All correspondence between the Army Corps of Engineers and the Kentucky River Authority since 1991 concerning the purchase, acquisition or transfer of lock and Dams No. 5, No. 6, No. 7, No. 8, No. 9, No. 10, No. 11, No. 12, No. 13, and No. 14 on the Kentucky River.
- All geo-technical studies for lock and Dams No. 5, No. 6, No. 7, No. 8, No. 9, No. 10, No. 11, No. 12, No. 13, and No. 14 on the Kentucky River.
- All studies and assessments performed since 1990 on lock and Dams No. 5, No. 6, No. 7, No. 8, No. 9, No. 10, No. 11, No. 12, No. 13, and No. 14 on the Kentucky River.
- All internal memorandum, studies, and reports on the possible purchase or acquisition by or transfer to the Kentucky River Authority of lock and Dams No. 5, No. 6, No. 7, No. 8, No. 9, No. 10, No. 11, No. 12, No. 13, and No. 14 on the Kentucky River.
- All studies on possible modifications to East Kentucky Power Company's intake on Pool 10 of the Kentucky River.
- All environmental assessments of Dam No. 10.
- All studies prepared by the Kentucky Water Resources Research Institute for the Kentucky River Authority on the yield of the Kentucky River and on the Kentucky River's supply capacity.
- All requests for proposals for new or updated studies of the yield of the Kentucky River and on the Kentucky River's supply capacity.



- All studies, reports, correspondence, internal memorandums and other documents related to the cost of repairing and upgrading Dams No. 5, No. 6, No. 7, No. 8, No. 9, No. 10, No. 11, No. 12, No. 13, and No. 14 on the Kentucky River.
- All studies, reports, correspondence, internal memorandums and other documents concerning federal and state environmental requirements that may be applicable to any plans for repairing and upgrading Dams No. 5, No. 6, No. 7, No. 8, No. 9, No. 10, No. 11, No. 12, No. 13, and No. 14 on the Kentucky River.
- Kentucky River Authority's authorized budget for Fiscal Years 1997 through 2002.
- All plans and/or procedures for operating valves on the Kentucky River.
- All correspondence with the Kentucky Division of Water concerning the operation of valves on the Kentucky River or any valve operating plans.
- All correspondence with the Army Corps of Engineers concerning the operation of valves on the Kentucky River or any valve operating plan.
- The minutes of all board meetings of the Kentucky River Authority since January 1, 1997.
- A transcript or notes of Stephen Reeder's presentation to the Lexington-Fayette Urban County Government Council on November 22, 1999.
- A transcript and any notes of the Kentucky River Authority's presentation to the Lexington-Fayette Urban County Government Council on June 21, 2000.
