
KENTUCKY PIONEER ENERGY, LLC'S MOTION
FOR EXTENSION OF TIME TO FILE POST-HEARING BRIEF

Kentucky Pioneer Energy, LLC ("KPE"), by counsel, petitions the Kentucky State Board on Electric Generation and Transmission Siting (the "Board") for an extension of time through and until Friday, March 21, 2003 to file its post-hearing brief (the "Brief") in the above captioned case.

By the procedural schedule established in this case by Order dated January 28, 2003, KPE is required to file its Brief no later than March 13, 2003. Due to certain data requests and informal conferences in other proceedings before the Kentucky Public Service Commission relating to KPE's Integrated Gasification Combined Cycle electric merchant plant project, certain key KPE personnel have not been available to complete the Brief. KPE advises the Board that the Board's Staff in this proceeding have no objection to this motion requesting the relief stated herein and that this motion will not unduly delay the proceeding or prejudice any other parties to the proceeding.
