- A1. CBT provides service in Kenton, Boone, Campbell, Gallatin, Pendleton and Grant Counties.
- Q2. Please identify which of the following service categories you provide in the counties named in question 1.

- A2. CBT is capable of providing all of the services identified in the question to most, if not all, of its customers located in the six counties of its Northern Kentucky operating area.
- Q3. Of the services you provide in Kentucky, what is the percent split by access lines between business and residential service?
- A3. As of March 31, 2003, 28.83% of access lines served business customers and 71.17% served residential customers.
- Q4. Of the services you provide in Kentucky, what is the percent split by revenue between business and residential service?
- A4. As of March31, 2003, the revenue split between business and residential service was 38.13 % and 61.87%, respectively.
- Q.5 What percent of your customers purchase services from your company at your filed tariff rates and conditions.
- A5. Over 99% of CBT's business customers purchase services at tariffed rates. In CBT's experience, however, more and more business customers expect customized offers everyday.
- Q6. Does your company sell its services through a company sales force, agents, or both?
- A6. CBT sells its services through both a company sales force and agents.
