The Commission staff has reviewed your application in the above case. This filing is rejected pursuant to 807 KAR 5:001, Section 2, for the reasons set forth below. These items are either required to be filed with the application or to be referenced in the application if they are already on file in another case.


Filing deficiency pursuant to 807 KAR 5:001:

- 1) Section 10(6)(o): List of all commercial or in-house computer software, programs, and models used to develop schedules and work papers associated with the filing. Include each software, program, or model; what each was used for; its supplier; brief description and specifications for the computer hardware and the operating system required to run the program.
- 2) Section 10(7)(b): Most recent capital construction budget containing at least period of time as proposed for any pro forma adjustment for plant additions.
- 3) Section 10(7)(d): Operating budget for each month of the period encompassing the pro forma adjustments.
- 4) Section 11(1)(b): Whether the debt is to be secured and if so a brief description of how it's secured.
- 5) Section 11(2)(c): Detailed estimates by USOA account number.



The statutory time period in which the Commission must process this case will not commence until the above-mentioned information is filed with the Commission. You are requested to file ten copies of this information within 15 days of this letter. If you need further information, please contact Scott Lawless of my staff at (502) 564-3940, Extension 239.
