Informal Conference

On October 15, 2003, an informal conference was held pursuant to an Order of the Commission, concerning the rate adjustment proceeding for Ohio County Water District ("OCWD"). The names of those present appear on the attached sign-in sheet.

Staff opened the discussion by explaining the necessity for the amended staff report and the differences in the calculation of the rates as proposed for OCWD by Staff. OCWD presented maps of its system and explained the proposed construction and its overall relationship with the entire system.

There was discussion among the parties concerning the debt structure of OCWD; the wholesale rate in the proposed schedule; line loss; and chemical costs. The Attorney General presented questions about the method used to calculate percentages for allocation of cost.

OCWD presented comments in the form of a letter, which indicated its agreement with the staff report. The parties were informed that, based upon the OCWD's acceptance of the Staff Report as amended, a formal hearing would not be required, but that the requesting party would need to inform the PSC if that party wished a hearing. Intervenor Jacqueline Mitchell agreed to inform the parties by October 17, 2003, if she still wished to proceed with the formal hearing.

The meeting was adjourned.
