PROPOSED AGENDA AND PROCEDURES FOR JANUARY 14, 2004 INFORMAL CONFERENCE, FILED BY COMPETITIVE CARRIERS OF THE SOUTH, INC.

Pursuant to the Staff's Notice of Informal Conference in this docket dated December 17, 2003, the Competitive Carriers of the South, Inc. ("CompSouth") hereby files this proposed agenda and procedures for the January 14, 2004 informal conference pertaining to hot cut issues. In general, the approach consists of using the morning for presentations by BellSouth Telecommunications, Inc. ("BellSouth") and CompSouth, which allow each to give an overview of their respective positions on the hot cut process and answer non-adversarial questions. This provides an educational background for, and places in context, the physical tours which follow in the afternoon. CompSouth proposes having two tours, one following the other, so that everyone from the Commission and the parties interested in attending will be able to receive the full benefit of the tour. Given the space constraints and noise level generally present at telecommunications facilities, it is our experience that fifteen people maximum is an appropriate number for each tour. This size allows those attending to be able to hear the presenters and observe their demonstration. A larger tour generally defeats the purpose of the effort. Having conducted similar presentations and tours in other states in this fashion with BellSouth, CompSouth submits

that this will serve as the most efficient use of the Commission's and parties' time, as well

as affording all in attendance the opportunity to fully see, hear, and participate in the

physical tour.

CompSouth has consulted with BellSouth regarding the details of locations and

appreciates their offer to host the morning presentations and nearby central office tour. The

BellSouth has agreed to provide the equipment for this purpose.
