

BellSouth served its First Set of Discovery in this case on October 10, 2003, and its Second Set of Discovery on November 24, 2003. As of today, BellSouth has not received a response to either set from Brandenburg Telephone Company, Inc.

BellSouth filed motions with the Commission on October 10, 2003 and November 24, 2003 asking the Commission to require carriers to respond to BellSouth's discovery. These motions are pending before the Commission at this time. BellSouth believes if the Commission is to make the determinations in this case, it is essential that Brandenburg Telephone Company, Inc. respond to BellSouth's discovery. BellSouth would prefer that responses were provided voluntarily; however, if Brandenburg Telephone Company, Inc. does not respond, BellSouth will have to file a Motion to Compel.

BellSouth respectfully requests that you promptly respond to BellSouth's discovery.
