

AT&T is a utility authorized to provide competitive local and long-distance services in Kentucky. As a competitive local carrier ("CLEC"), AT&T has a direct interest in the Section 251 unbundling obligations of incumbent local exchange carriers, and intends to participate in this matter. AT&T's participation is likely to present issues that will assist the Commission without unduly complicating the proceeding.


