Comes the applicant, Kentucky-American Water Company, and herewith gives notice of the filing herewith of corrected Exhibit 37, Schedules A, B, C, D, E, M and supporting workpapers. This corrected filing incorporates the responses to the Attorney General's First Data Requests, Items 108, 111, 113 and 138; Attorney General's Second Data Requests, Item 29; Lexington-Fayette Urban County Government's Second Data Requests, Item 24, and the Public Service Commission's Second Data Requests, Items 79 and 99.

This corrected filing reduces the revenue requirement in Tri-Village by \$31,166 and in Elk Lake by \$11,511. This corrected filing increases the revenue requirement in the Central Division by \$129,054; \$118,035 of which is generated thru increases to going level revenues from public fire hydrant charges in the forecasted test year. The revenue deficiency therefore increases by \$11,019, for which the applicant does not seek recovery.
