# ATTORNEY GENERAL'S WRITTEN COMMENTS FOR KENTUCKY-AMERICAN WATER'S EMERGENCY PRICING TARIFF PROPOSAL

The Attorney General tenders his written comments to the Kentucky-American Water Company's report to the Commission for an Emergency Pricing Tariff. The Attorney General notes the following concerns.

During a period in which there is a suppression of or reduction in water production, there will be decreases in certain expenses, for example, chemicals and electricity. Thus, there will be incremental savings associated with the implementation of an Emergency Pricing Tariff, and any mechanism to calculate "over/under" recovery should track or otherwise reflect incremental savings as well as incremental expenses.

A more fundamental concern is that while drought conditions are outside the control of Kentucky-American Water, the responsibility for meeting the reasonably expected demands of its customers (including the demands during reasonably expected drought conditions) is upon Kentucky-American. The Attorney General does not object to a mechanism that will prevent financial harm to Kentucky-American and that will also protect the Company's customers during the occurrence of a catastrophic event. He does not, however, support a mechanism that serves to remove Kentucky-American from adverse consequences resulting from its decisions for meeting reasonably expected business conditions. The Attorney General does not want to see a shift of drought planning risks from Kentucky-American to its customers.

WHEREFORE, the Attorney General respectfully requests his Written Comments to Kentucky-American Water's report.
