**RESPONSE TO DATA REQUEST OF COMMISSION STAFF DATED DECEMBER 23, 2004**

Clark Energy Cooperative, Inc. of Winchester, Kentucky, hereinafter referred to as "Clark", respectfully submits the following responses to the Commission's information request of December 23, 2004:

Question No. 1: Provide an additional original of the subdivision map that was attached to the application showing the existing and revised territorial boundary.

Answer: An additional original of the subdivision map illustrating the existing and proposed territorial boundary will be delivered at the same time all original paper documents are filed with the Commission.

Question No. 2: Explain in detail why the territorial boundary is being revised to conform to property lines in only half of the Fieldstone Estates Subdivision.

Answer: Clark's application to amend the territorial boundary only pertains to the initial or "Block 1" phase of Fieldstone Estates where initial residential expansion is now planned. A final development plan and plat for this initial phase of residential expansion has been submitted to and approved by Richmond-Madison Co. authorities. Alternately, only a preliminary plat illustrating the proposed layout of all other areas of Fieldstone Estates has been prepared. The preliminary layout and plat is subject to change until a final subdivision plat for these areas is developed and approved by Richmond-Madison Co. authorities. Clark and Kentucky Utilities have not proposed any changes to the territorial boundary until a final plat for remaining areas of Fieldstone Estates has been approved.

A copy of the final plat prepared by the surveyor, Charles E. Black Consulting Engineers in Richmond, KY illustrates the initial or "Block 1" phase of Fieldstone Estates approved for development. Similarly, a copy of the preliminary plat by Charles E. Black illustrates

both the final approved "Block 1" phase and the remaining preliminary or proposed sections of Fieldstone Estates. Both plats are being filed electronically as part of Clark's response to the Commission's information request. An original of both plats will be delivered at the same time all original paper documents are filed with the Commission.


Question No. 3: How and when will the territorial boundary in the other half of the subdivision be resolved to avoid having new electric-consuming facilities located in two adjacent territories?

Answer: Charles E. Black Consulting Engineers has not yet prepared and submitted a proposed final plat of the remaining areas of Fieldstone Estates to Richmond-Madison Co. authorities for approval. Similarly, Clark and Kentucky Utilities have not received any draft of a proposed final plat of these areas. The parties, however, will propose changes to the territorial boundary in remaining areas of Fieldstone Estates after a proposed final plat draft is prepared and submitted to Richmond-Madison Co. authorities for approval. Clark and Kentucky Utilities will cooperate to develop any proposed changes to their respective territorial boundary for Commission approval as the parties have in this case and numerous other territorial cases previously approved by the Commission.
