APPLICATION

Clark Energy Cooperative, Inc. of Winchester, Kentucky, hereinafter referred to as "Clark", respectfully states:

1. The full name and address of Applicant is:

 Clark is a corporation, duly organized, created and existing by and under the laws of the State of Kentucky, and is engaged in the business of supplying retail electric service in Bath, Bourbon, Clark, Estill, Fayette, Madison, Menifee, Montgomery, Morgan, Powell, Rowan and Wolfe Counties in Kentucky.

A certified copy of the Articles of Incorporation has been previously filed in Case No. 92-219 with the Kentucky Public Service Commission, hereinafter referred to as the "Commission". An Amendment to the Articles of Incorporation pertaining to a name change from Clark Rural Electric Cooperative Corporation to Clark Energy Cooperative, Inc. was filed by letter dated July 17, 1997.

- 3. Clark is required to file an Application with the Commission seeking authorization of the Applicant's request that the Commission amend the Applicant's service territory boundary with Kentucky Utilities Company, hereinafter referred to as the "Authorization" per KRS 278.018(6) and KRS 278.020(1).
- 4. Clark's Application requests the Commission issue an Authorization to amend the Applicant's service territory boundary with Kentucky Utilities Company at Fieldstone Estates Subdivision, Phase 1 in Richmond, Madison County, Kentucky. The Applicant and Kentucky Utilities Company have executed an agreement to amend the boundary as prescribed within the <u>Agreement to Amend Territorial Service Area Boundary</u>, hereinafter referred to as the "Agreement", filed with this Application. The Agreement incorporates a subdivision map illustrating the amended boundary, which has also been executed or signed by the parties and filed with this Application.
- 5. The Agreement will realign the service territory boundary to coincide with subdivision lot boundaries to prevent any duplication of power line facilities, equipment, and appurtenances.
- 6. The Agreement will not affect the service territory or like facilities of any other public utilities, corporations, or persons and will permit the Applicant and Kentucky Utilities Company to economically provide electric service to their respective customers.
- 7. The Agreement will not result in any reassignment of any existing customers to a different electric supplier or require any new franchises or permits to be filed with the Commission.
- 8. This Application and supporting documentation is being filed using the procedures and guidelines of the Commission's electronic filing initiative. The Commission has already assigned Clark a user ID, password and established Case No. 2004-00382 for Clark to electronically file this Application.
