Dear Mr. Derouen:

Under the Administrative Provisions of the SQM Plan, notice is hereby provided that AT&T has recently implemented certain system changes in the Southeast region. Specifically, as of August 31, AT&T retired the Loop Maintenance Operations System ("LMOS") interface that stores the assignment and selected account information for use by downstream OSS and AT&T personnel during provisioning and maintenance activities. As a result of the retirement of LMOS, this completes the migration to the Work Force Administration/Control ("WFA/C") System interface. Also included in this migration is the Network and Services Database ("NSDB") which serves as the database for WFA/C and is a central database for customer circuit and services information. Interested parties, including Competitive Local Exchange Carriers ("CLECs"), have been advised of this change through standard CLEC communications, including monthly Change Control Process ("CCP") meetings and the attached Accessible Letter ("AL"): CLECSE11-230 (dated December 12, 2011) is included as **Attachment I**.

Although this OSS change does not substantively change the SQM Plan, the SQM Plan documentation must be updated to accurately reflect the retirement of the LMOS interface. Accordingly, AT&T has made minor, administrative updates to the SQM Plan documentation. For the Commission's convenience, a red-lined version of the pages of the SQM Plan which have been updated are included in this filing as **Attachment II**. 

It is important to note that from a performance measurement perspective, the migration to the WFA/C interface will have **no impact** on the creation or review of trouble tickets within measures currently contained in the SQM Plan.


