In reviewing the data associated with the June 2008 service order accuracy ("SOA") report,<sup>1</sup> BellSouth Telecommunications, Inc. d/b/a AT&T Kentucky identified certain errors with the SOA performance results. Accordingly, pursuant to SEEM § 4.5.3,<sup>2</sup> AT&T Kentucky is withholding Tier I SEEM payments associated with the June 2008 SOA report pending further investigation. Upon conclusion of its investigation, AT&T Kentucky will re-run the data and will pay, with appropriate interest, any Tier I SEEM remedies associated with the June 2008 SOA report.

<sup>1</sup> In general, the SOA report measures the accuracy and completeness of CLEC service requests by comparing CLEC service requests to the completed service order after provisioning has been completed. The June 2008 SOA report contains data for service orders completed in May 2008. The June 2008 SOA report was posted on the PMAP website on July 31, 2008.

<sup>2</sup> SEEM § 4.5.3 gives AT&T Kentucky the right to "petition the Commission to consider [SEEM payment] relief based upon other circumstances." Here, AT&T Kentucky is not seeking relief of its SEEM obligations. Rather, AT&T Kentucky is requesting additional time to investigate and review performance data that was impacted by the April OSS release prior to making Tier I SEEM payments associated with such data.


