
Consistent with Appendix F of the Service Quality Measurements Plan adopted by this Commission on August 31, 2005, BellSouth Telecommunications, Inc., d/b/a AT&T Kentucky ("AT&T Kentucky"), is filing a Proposed Data Notification Report for the January 2010 data month. There are no changes to be placed on the Proposed January 2010 Data Notification Report. Also attached for filing is a copy of the 2010 PMAP Notification Schedule.

There is one additional matter that AT&T would like to bring to the attention of the Commission and the parties. On the September 2009 Data Notification filed on August 4, 2009, AT&T provided notice that it would modify the code in accordance with the business rules so that the Local Interconnection Trunk volume is only reported in the disaggregation for the Reject Interval measure. Although AT&T expected to make this change with September 2009 data, it will be implemented with January 2010 data instead (RQ9448).
