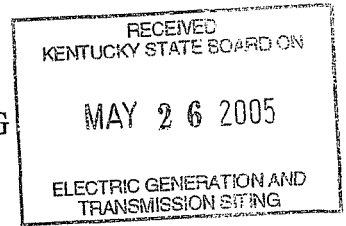

REQUEST FOR EXTENSION OF TIME
BY DTE WICKLIFFE, LLC

Comes now DTE Wickliffe, LLC (“DTE”), by counsel, and requests an extension of time to respond to the Public Service Commission *on behalf of* the Kentucky State Board on Electric Generation and Transmission Siting’s (the “Board”) First Data Request and to respond to Kentucky Utilities Company’s (“KU”) Request for Information (collectively the “Requests”). DTE specifically requests an additional period of time, or up to and including June 30, 2005, in which to respond to both Requests. As grounds for its Request for Extension, DTE states that the same is necessitated by the scope, nature and volume of the information requested as well as the complexity of these proceedings. DTE states that the requested extension is not unreasonable and that no prejudice will result from the same. DTE states that it has spoken to counsel for KU and they have no objection to the request. Additionally, DTE supports and has no objection to the Board granting a similar 30 day extension to KU to file its Direct Testimony.

WHEREFORE, DTE Wickliffe, LLC, respectfully prays that its Request for an Extension be granted and that it be afforded all other necessary and proper relief.




