NOTICE OF PROCEDURAL SCHEDULE

On May 31, 2005, the Illinois Municipal Electric Agency and the Indiana Municipal Power Agency filed a joint application with the Board for approval of their partnership with Louisville Gas and Electric Company and Kentucky Utilities Company in a project to construct a 750 MW addition to the existing generating station in Trimble County, Kentucky. On June 8, 2005, the Board issued a preliminary procedural schedule. Since that date, numerous Trimble County residents have requested a local public hearing.

The Board therefore finds that a local public hearing should be scheduled for July 6, 2005 at 6:00 p.m., Eastern Daylight Time, at the Trimble County Office of the Kentucky Cooperative Extension Service, 43 High Country Lane, Bedford, Kentucky.

The attached revised procedural schedule shall apply to this case.
