NUVOX COMMUNICATIONS, INC.'S MOTION FOR FULL INTERVENTION

NuVox Communications, Inc. ("NuVox"), by counsel, pursuant to 807 KAR 5:001

Section 3(8), hereby submits its Motion for Full Intervention to the Kentucky Public Service

Commission (the "Commission") and requests the issuance of an Order permitting it to intervene as a party in this case. In support of its Motion for Full Intervention, NuVox states as follows:

- 1. On March 31, 2006, BellSouth Corporation ("BellSouth") and AT&T, Inc. ("AT&T") (collectively referred to herein as the "Joint Applicants") filed with this Commission for Approval of Indirect Transfer of Control Relating to the Merger of AT&T, Inc. and BellSouth Corporation.
- 2. NuVox is a facilities-based competitive local exchange carrier ("CLEC") with its principal place of business located in Greenville, South Carolina. NuVox provides telecommunications services throughout the territories serviced by BellSouth, including Kentucky, and in seven (7) states in which AT&T does business. NuVox directly deals with the Joint Applicants frequently in the conduct of its business. Thus, this case involves issues which are directly relevant to NuVox's business and ongoing operations.

3. As a CLEC doing business in the above-referenced territories, including Kentucky, NuVox has a unique perspective on the proposed merger of the Joint Applicants and, should it be permitted to intervene, NuVox will be able to help develop facts that will assist the Commission in full consideration of the proposed transaction. If allowed to intervene in this docket, with the limited exception as stated in NuVox's Motion for an Enlargement of Time to File Data Requests to the Joint Applicants which accompanies this Motion, NuVox will comply with the existing scheduling docket as established in the Commission's Order dated April 12, 2006 so as not to unduly burden the Commission, the Commission's staff or the other parties.

4. NuVox requests that it be granted leave for full intervention with the right to fully participate in this proceeding as a party, and that the undersigned counsel for NuVox be allowed to participate in all hearings held regarding this docket, be served with filed testimony, exhibits, pleadings, correspondence and all other documents submitted by the parties and be certified as a party for the purposes of receiving service of any petition for rehearing or judicial review.
