MONTHLY STATUS REPORT

Pursuant to Ordering Paragraph 12 of the Commission's April 16, 2007 Order in this matter, Joint Petitioners provide the following status report. Approvals for the Proposed Transaction have been obtained in all states in which they were sought: Hawaii, Tennessee, Virginia, Maryland, New Mexico, Arizona, West Virginia, Kentucky, California, New Jersey, Illinois, New York and Pennsylvania.

The Initial Public Offering of 58 million shares of American Water Works Company, Inc. common stock occurred on April 23, 2008. In June 2009, additional offerings occurred totaling 15.4 million shares resulting in a reduction of RWE's ownership of American Water to less than 50%. In August 2009, additional offerings occurred totaling 40.25 million shares resulting in a reduction of RWE's ownership of American Water to approximately 24%.
