

**MONTHLY STATUS REPORT**

Pursuant to Ordering Paragraph 12 of the Commission's April 16, 2007 Order in this matter, Joint Petitioners provide the following status report. Approvals for the Proposed Transaction have been obtained in all states in which they were sought: Hawaii, Tennessee, Virginia, Maryland, New Mexico, Arizona, West Virginia, Kentucky, California, New Jersey, Illinois, New York and Pennsylvania. As for the status of filings with the Securities and Exchange Commission, the review process for the Form S-1 Registration Statement that was attached to the August 29, 2007 Monthly Status Report is underway. Due to market conditions, RWE has indicated that the initial public offering will not occur before the end of 2007.


