MINUTES OF THE LOCAL PUBLIC MEETING
BRYAN STATION HIGH SCHOOL – AUDITORIUM

APRIL 7, 2009 5:30 P.M.

Chairman David Armstrong called the meeting to order at approximately 5:30 p.m., welcoming the attendees, and introduced the other Commissioners and PSC Staff in attendance. Chairman Armstrong gave a brief introductory statement explaining the purpose of the meeting, which was to hear public comments on Kentucky-American Water Company's ("Kentucky-American") application for a base rate increase. He informed the attendees that they could also file written comments and that forms for such comments were available at the reception table. Chairman Armstrong also noted that the meeting was being recorded on videotape. After explaining the purpose of the application and the procedure and protocol for the public meeting, Chairman Armstrong invited those who had signed up to speak to come forward to give their comments, and each speaker was allowed five minutes to speak.

The following five speakers addressed the Commission: Jane Osman, Jane Bogardus, Jim McWilliams, Tom Kriegel, and Don Pratt. These speakers discussed a variety of issues, including foreign ownership of Kentucky-American, whether Kentucky-American may be eligible for financing from the federal stimulus package, the cost of Kentucky River Station II included in the rate calculations before the plant is operating, and Kentucky-American's rate structure.

All persons in attendance were asked to sign in and provide their addresses for the record. The sign-in sheets are attached hereto. At the conclusion of the public meeting at approximately 6:15 p.m., Chairman Armstrong thanked the speakers and attendants for their participation and then dismissed the meeting. Members of Commission Staff and employees of Kentucky-American were available after the meeting for individual questions.
