Dear Ms. Bridwell:

Pursuant to Appendix C, Commitment No. 24 in the aforementioned case, Louisville Gas and Electric Company (“LG&E”) and Kentucky Utilities Company (“KU”) (collectively “the Companies”) hereby notifies the Commission that LG&E and KU Energy LLC contributed (1) \$70 million (\$30 million to LG&E and \$40 million to KU) on December 30, 2021, and (2) \$70 million (\$10 million to LG&E and \$60 million to KU) on June 29, 2022 of additional paid in capital. The Companies significant capital expenditure program requires equity contributions from LG&E and KU Energy LLC to maintain a balanced capital structure. LG&E and KU inadvertently omitted reporting the capital contributions to the Commission in the prescribed timeframe.

Also, pursuant to the reporting requirements for Commitment No. 24, the accounting entries for the equity contributions are as follows:
