

**RESPONSE OF VECTREN TO HENDERSON WATER UTILITY  
MOTION TO COMPELL RESPONSE AND FOR EXTENSION OF TIME**

Comes now Southern Indiana Gas & Electric Co., d/b/a Vectren Energy Delivery of Indiana, Inc. (“Vectren”), by counsel, in response to the motion of Intervenor, Henderson Water Utility (HWU), to compel response from Vectren and for extension of time to answer first information requests, respectfully responds as follows:

On August 23, 2010, Intervenor HWU filed with the Board a data request for Applicant Vectren. Item number 10 of that data request included a request to provide the “Diagram of Support Structures” identified in the Table of Contents of the Application.

By response dated September 3, 2010, Vectren directed HWU to the materials at Tab 5 of Vectren’s Application for Certificate to Construct Nonregulated Electric Transmission Line, which was previously served on the City of Henderson per the statutory and regulatory requirements governing the Siting Board process. A hard copy and electronic copy of the requested information were filed with the Siting Board at the Public Service Commission on July 15, 2010 at the initial time of filing and are available for public viewing. HWU now seeks to

compel Vectren to produce information already provided and available to all Intervenors and the public as part of the record of this proceeding.

In light of the requested material having been readily available to HWU throughout this proceeding, Vectren does not object to the requested three day extension of time from the date of this response, September 13, 2010.
