The Plans and Profiles for Phase Seven are the last of such plans to be filed for the project approved by the Board in the above referenced matter.

The final route for Phase Seven was the subject of a recent route modification approved by the Board by Order dated September 26, 2012. As a result of this route modification, Vectren also herein submits revised Plans and Profiles for Phase Six (6), which were filed with the Board on May 23, 2012. The route modification for Phase 7 reduces the length of Phase 6 and eliminates the need for one support structure. Vectren previously halted construction on Phase 6, in order to resolve the Phase 7 route issue, so no structures will have to be moved. Thus, the attached Plans and Profiles for Phase 6 hereby amend and replace the previous Phase 6 filing and represent the final, to-be-contructed location of all structures in Phase 6.

With this filing of Phase 7 and amended Phase 6 Plans and Profiles, Vectren has now filed with the Siting Board a complete survey of the final location of the line and its
